

Floyd County Wildlife Club
Monthly Board Meeting March 4, 2021

Monthly meeting was called to order by Eddie Wallace. Board Members and Officers in attendance Bobby Bell, Ken Kizziah, Russell Rogers, George Taylor, Ronnie Motes, Laura Headrick, Johnny Nutter, Bob Clark, Terry Weeks, Fletcher Christian, Eddie Wallace, Joe Baker, David Pledger, and Mike Stover.

Mike Stover read the minutes from the February 4, 2021 FCWA Meeting. George Taylor made a motion to accept the minutes as read. The motion was seconded by Ronnie Motes, and a vote taken. The motion carried.

Joe Baker read in the names of 7 new applicants for FCWA Membership. Johnny Nutter made a motion to accept all applicants as presented. A second to the motion was made by Fletcher Christian. A vote was taken and the motion carried. Eddie Wallace reported we have 733 FCWA members at this time.

Financial Report:

David Pledger provided a verbal report that the FCWA primary checking account has a balance of approximately \$28,000.

Business:

- The FCWA Club House was named the Roy F. Gardner Building many years ago after one of the original founding members that took extraordinary steps to insure the ongoing survival of the Floyd County Wildlife Association. Floyd Farless took a moment at the Board Meeting to reflect on Mr. Gardner's contribution to the Club and that the plaque with his name had been damaged and removed many years ago.

Following this conversation Eddie Wallace made a motion that Floyd Farless would head the effort to replace the original plaque with approval to spend up to \$500 for this purpose. The motion was seconded by Ronnie Motes and vote taken. The motion was approved.

- Russell Rogers recommended Range Fees be established for the FCWA Archery Range. After conversation Bobby Bell made a motion that the daily range fee be \$6 for Club Members and \$10 for Guest. Also a club member could purchase an annual range pass for \$30. These fees are priced the same as the current pricing for the FCWA Rifle Range. Fletcher Christian seconded the motion and a vote was taken. The motion was approved.
- Warren reported 18 people attended the February Archery Match and the next match will be on March 27th. Warren also reported that the FCWA targets will need to be replaced later this year and new targets could be acquired for possibly \$7,000 to \$8,000. After discussion it was agreed to come back to the new target acquisition later this year.

- Mike Stover mentioned the CMP Match and Archery Match are on the same day this month and requested both events to park as efficiently as possible. We are hoping for good attendance on both and all will work to manage parking.
- Ronnie Motes requested the Club revisit a better area for patterning shotguns and spring loaded hand thrower for clay targets. After discussion it was agreed to see what options might be available.

There being no additional business a motion to adjourn was made by David Pledger. The motion was seconded by Johnny Nutter and the motion carried.
